HIGHWAY SUPERINTENDENT REPORTS

The Highway Superintendent, Jon MacSwan, reported as follows:

- Next week restoring road shoulders from the July storms.
- Culverts are plugged and they are working on fixing those.
- They are behind on brush pick up.

WATER SEWER REPORTS

The Highway Superintendent, Jon MacSwan, reported as follows:

- Water service connected on Eagle Drive and Old Shawnee Rd.
- Replaced valve on Baer Rd. because t-bolts rotted and caused a leak.
- New build on Shawnee Rd.

ATTORNEY REPORTS

No reports.

TOWN ENGINEER-WENDEL

Tim Walck, Engineer, reported as follows:

Wendel provided a proposal for the Town Board to survey an area on Ridge Rd. that was affected by the July rain storm and impacted several properties and farms. Approval for this proposal was given on August 3, 2021.

An old stone drainage way collapsed under the pressure of the water from the storm. This was east of Faery's Nursery. This caused severe flooding to Faery's and several homes and farms that are nearby. Wendel surveyed the properties involved and shot elevations across Rt. 104. There will be a meeting with the NYS DOT Hydraulic Engineer tomorrow and then the DOT meets with the Town Monday morning. The preliminary size for the new culvert is 24" x 36".

Several people in the audience voiced their concern around the flooding and how they had damage in one way or another.

A brief discussion took place.

CONCERNS OF CITIZENS

- One resident asked if there will be a change to the NYS Solar Law now that the Governor has resigned. Supervisor Ellis stated there is no indication of any change. The Town has voiced its concerns over the Visual Impact Statement and asked for a meeting to discuss it. Another resident indicated that Kathy Hochul made a blanket statement that she is aware of what Governor Cuomo was instrumental in and has the ability to keep things going.
- A question was asked of the Board as to whether or not a Dollar General was going up on Upper Mountain Road and Thrall. The Supervisor responded by saying, 'not that we know of'.
- Did a survey go out to residents regarding water/wells on properties? It was not a survey from the Town; it was from Cypress Creek as a check off item with regard to ground water.
- With the current flooding, the potential solar panels could leech into Bull Creek and affects the soy and corn that will ultimately affect the animals that use it for food. In addition the Monarch Butterflies are being affected by the changes in the environment. Jon MacSwan indicated that his employees do not mow the Brown Fields before fall because of the Monarch Butterflies. Supervisor Ellis advised that she write a letter to the editor to get the information out.
- Town residents are frustrated that their concerns re: solar issues are falling on deaf ears. The answer from Supervisor Ellis was that it is not so much falling on deaf ears as it is the process of the 94C. The Town is frustrated as well.
- Is the Town continuing talks with Cypress Creek. Supervisor Ellis indicated yes, they are. It is the best way to keep informed of what is going on throughout the process. Under Article 10 the Town knew what was being done on behalf of Cypress Creek, however under 94C it does not.

Councilman Foe also indicated the frustration on behalf of the Town Board with regard to Cypress Creek and the 94C rules/process. They must keep the communication open throughout the process.

- Was the July storm declared under FEMA. Assemblyman Morrinello, Senator Ortt and Senator Norris wrote a letter to the Governor asking for a declaration of emergency. Niagara County declared an emergency in Niagara County and that is still in effect.
- How do residents know if there will be a delay in refuse service? The Town of Cambria does NOT have a social media account so all information is posted on the website: www.townofcambria.com
- 94C-Are there any minimal environmental guidelines that the Federal Government requires? Supervisor Ellis indicated that the Federal Government is not in the business of renewable energy siting, that is up to the states.

Supervisor Ellis reported on the following:

The Corona Virus Local Fiscal Recovery Fund:

There was correspondence at one point that stated the Town of Cambria would receive one million dollars. The problem because the Town is under 50,000 in population it is filtered by the state. The state gets the money and then sends it to the Town. Another letter was received a while back stating that the Town would receive \$586,833.00. On 7/22/2021 there was a deposit into the Town's account from the NYS Comptroller in the amount of \$293,416.55 (half now and half in 2022). There are very strict guidelines as to how the money is to be spent; Water/Sewer/Broadband. There may be some expanded interpretations of those guidelines.

NEW BUSINESS

PELLICANO PROPERTY: 4660 RIDGE ROAD, LOCKPORT

Town Board is in receipt of a request from Frank and Mary Pellicano, 4660 Ridge Rd., to convert the restaurant portion of the property into a residential rental property. Supervisor Ellis is recommending the request be sent to the Planning Board for its review and recommendation. It is already zoned as Planned Development.

Upon a motion duly made by Councilman Foe and seconded by Councilman Hurtgam, it was resolved to refer the request from Frank and Maria Pellicano dated July 2, 2021, to convert the old Twin Oaks restaurant into a residential rental property, to the Planning board for their review and recommendation.
