### **CONCERNS OF CITIZENS**

David Godfrey, Legislator -

Broadband Update:

Governor Cuomo handed out a total of 57 million dollars in the rounds for the broadband initiative in order to bring cable/high speed internet to all homes in rural areas. The only vendor in Niagara County to receive funding directly from the Governor is HughsNet, a satellite company. \$5,400.00 was allocated to the Town of Cambria for 24 homes. This is \$225.00 per home, and does not include cable. The FCC requires service on a road with 20 homes per mile. Charter Communications stated they would do service with 15 homes per mile. Out in rural areas there are not 15 homes per mile, they are scattered and from a business perspective it is not cost beneficial.

There will still be meetings and hearing by the FCC to find out where are the Federal dollars to fill the void in rural areas and to get high speed, affordable, reliable internet, as the Governor promised.

## CORRECTIVE ACTION PLAN (CAP); NYS COMPTROLLER AUDIT REPORT

# ADDITIONAL MATTERS MORATORIUM

Supervisor Ellis indicated that the Town Board is taking an action that they do not like to take. However, they feel this is the only way to get organized in terms of the Zoning Ordinance. This will be addressing some issues that have come up with a couple of wineries and any potential new wineries in the Town.

The Town Board would like to declare a Moratorium on new wineries, breweries, distilleries, and meaderies in the Town of Cambria for a period of one year. During this year the Town Board will review applicable state guidance and instructions and also look at the Zoning Ordinance and develop some corrective action. At the present time it would not impact anyone who is currently operating in the Town.

Whereas, the NYS Liquor Authority is issuing Farm Winery License to applicants whose proposed operating sites happen to be in established neighborhood, such sites being inappropriate for the location of such an operation, such an operation will unreasonably disrupt and alter the essential character and environment of the neighborhood to the detriment of the other residents; and

Whereas, but for the issuance of the Farm Winery licenses to such applicants, the location of such an operation in an established neighborhood would be prohibited by the provisions of the Town of Cambria Zoning Ordinance; and

Whereas, the Town Board desires the opportunity to investigate and study this problem and make such amendments to the Town Zoning Ordinance as may be deemed appropriate to protect established neighborhoods within the Town from being disrupted by the inappropriate siting of such operations;

Now Therefore be it resolved, that the Town Board of the Town of Cambria hereby adopts a Moratorium on the establishment and opening of wineries, micro-breweries, distilleries and meaderies, within the Town of Cambria for a one year duration from the date of adoption of this Resolution to give the Town Board the opportunity to investigate and study the situation and develop amendments to the Zoning Ordinance to address the problems and issues being created by the issuance of Farm Winery Licenses.

Upon a motion duly made by Councilman Foe and seconded by Councilman Hurtgam, it was resolved to approve the above resolution on the Wineries, Micro-Breweries, Distilleries and Meaderies as read by Robert Roberson, Town Attorney.
